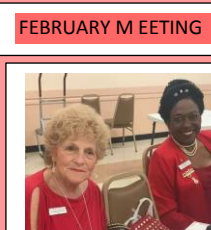

LEGISLATION: From the desk of Jennifer Nickel, CFWC Public Policy Chair

The Fact Sheet for CFWC authored Senate Bill SB 1104 is in!

CFWC is listed as the sole bill "sponsor" since we are the original authors of the bill and Senator Richard Roth, Incoming Senate Pro Tem Toni Atkins, Senate Minority Leader Patricia Bates and key policy maker Senator Nancy Skinner are listed as the bill "authors". While in the version used by the Senate we are credited as the source for the bill, CFWC opted to use the space more efficiently so that our club can better use it to lobby for support from your family, friends, neighbors and strangers on the street.

Digital copies are free and paper copies are can be had for 2.5 cents if you go to your local Office Depot/Office Max and use your GFWC Membership Discount. We can turn ANY project into a Legislation Project by handing out copies of the Fact Sheet. Please use email blasts to share this with your contacts and telephone blasts to get your members to contact their representatives. Remember that this bill has the bipartisan support and seeks to help families better protect their children from traffickers with by giving them easy access to the information they need to know. Since most people are against the idea of children being trafficked in this State, you will be doing EVERYONE a service by empowering those around you to help CFWC in our efforts to get this bill passed into law. We NEED your support as our bill sponsors have told us that they need community support to contact legislators in order to get the votes necessary to pass this bill.

LEGISLATIVE COUNSEL'S DIGEST

SB 1104, as introduced, Roth: Pupil safety: human trafficking prevention resources.

Existing law authorizes a school district to provide sexual abuse and sex trafficking prevention education, as defined, encourages school districts to collaborate with outside consultants, including law enforcement, with expertise in sexual abuse and sex trafficking prevention education in order to create school safety plans to address those threats, and authorizes in-service training to be conducted periodically, as provided.

This bill would require a school district to work with the schools of the school district to identify the most appropriate methods of informing parents and guardians of human trafficking prevention resources and to implement the identified methods by an unspecified date. By imposing additional requirements on school districts, the bill would impose a state-mandated local program. The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement. This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

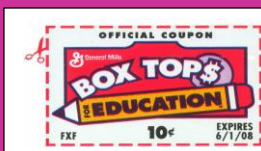

BILL TEXT: THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

1. Section 49381 is added to the Education Code, to read A school district shall work with the schools of the school district to identify the most appropriate methods of informing parents and guardians of human trafficking prevention resources and shall implement the identified methods by Ss.
2. If the Commission on State Mandates determines that this act contains costs mandated by the state, reimbursement to local agencies and school districts for those costs shall be made pursuant to Part 7 (commencing with Section 17500) of Division 4 of Title 2 of the Government Code.
